In an electronic The Jury Rules court, whenever the Registrar is required, under section 13 1 of the Act, to compile a panel from the jury list, he or she must arrange for the electronic selection of a sufficient number The Jury Rules names from the list to ensure enough jurors for the period in respect of which the panel is to be used.
